The Initiative for Strategic Litigation in Africa (ISLA) is a Pan-African and feminist initiative which engages the rule of law within African domestic and regional courts to advance sexual and women's human rights. We believe that strategic litigation can reframe understanding of entitlements before the law, challenge legal discourse on human rights violations, hold States and other duty bearers accountable to violations of human rights (especially those grounded in gender and sexualities), and develop new norms. Our work is also based on the belief that strategic litigation is a powerful tool for social change because it has the capacity to work in multidimensional ways, both within a given context and, critically, across contexts. We highlight positive developments and emphasise cross-learning from various countries on the continent.

The Sexual Rights Litigation Network (SXLN) aims to build a body of actors that can hold states accountable for violations against persons based on their gender and/or sexuality by nurturing partnerships between movements and lawyers working together on social change through strategic litigation at national, regional, and international level.

About the Network:

The Sexual Rights Litigation Network (SXLN) works in various countries to support social movements and individuals who would like to use the law and litigation in particular in order to respond to sexual rights and SOGIE-based violations in particular. The objectives of the Sexual Rights Network are four-fold: developing social movements that use the law and courts in particular as an advocacy tool, developing a pool of movement lawyers who are embedded in the movements and work to support the movements to achieve their goals, and to hold States accountable for SOGIE-based violations across the continent; strengthening our network partners' ability to do strategic litigation and feminist litigation in particular and working with partners to create an enabling environment for doing strategic litigation.

What to Expect

Successful applicants will attend sessions to learn about strategic litigation, as well as have an opportunity to grow this area of their practice, identify and develop cases for submission before national courts or regional human rights systems in order to develop jurisprudence before domestic courts and African Human Rights Systems.
